Commerce Wizard – 2018

This initiative is aimed at motivating the students to achieve excellence in commerce stream.

International Accountants Day:

The International Accountants Day is celebrated yearly on November 10 across the world and the World Accounting Bodies organizes programmes to commemorate the occasion, which dates back to the year 1494 when Venetian mathematician Luca Bartolomeo de Pacioli published an epic tome that included an in-depth look at bookkeeping practices. The publication brought out on 10th November 1494 spoke about the double-entry bookkeeping and it is in his honour that International Accountants Day is celebrated. His book, Summa de Arithmetica, Geometria, Proportioni et Proportionalita, described keeping accounts for assets, liabilities, capital, income, and expenses, much like the systems we the accountants use today in balance sheets and income statements.

SIRC, as part of the celebration will organize programmes on 10th November 2018. These programmes are to be organized with a view to popularize the commerce education amongst the student's community and other stakeholders.

Nostalgic Moments:

SIRC, through this column in the previous issues has brought out certain important events and milestones of ICAI as well as SIRC for the information of the readers. SIRC is once again happy to share certain occasions happened in the month of November which is considered as significant in the annals of ICAI/SIRC.

- * The Decentralized Office of ICAI started functioning from 1st November 1974. This was the first decentralization effected by ICAI across country. The office was inaugurated by Shri N.C. Krishnan, then President, ICAI on 28th October 1974 (Ref. Page No. 453 of Vol. XXIII of ICAI Journal).
- * For the first time ICAI introduced the Post Graduate Course, viz., Management Accountancy Course from November 1959 (Ref: Page No 75 of September 1958 issue of Journal). The Examination was held on 5th, 6th, 7th, 9th and 10th November 1959.
- * For the first time on 20th November1985 SIRC started the Felicitation Function to the successful candidates of Final Examination from Southern Region and this continued for decades. In a way SIRC can boast to be the forerunner of the Convocation Function now being held by ICAI.
- * The Data Centre (Virtual Institute Project (VIP) was inaugurated on 22nd November 2003 by Shri R. Bupathy, then President, ICAI.
